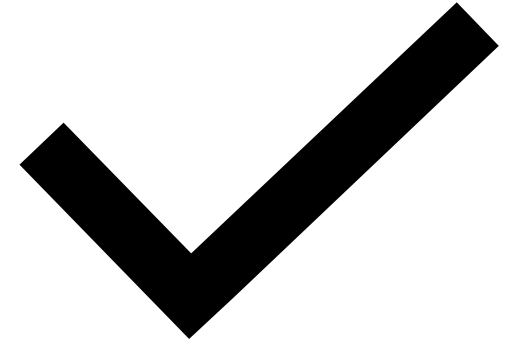


Pre-Entry Screening Questions Cleared Today



Place this card face-up on the dashboard of your car prior to entering the Brookhaven Lab site if you answer “No” to all of these questions (see instructions on other side)

Before leaving for work today, please check your temperature and ask yourself the following questions:

- DO YOU CURRENTLY HAVE COVID-19?
 - Are you currently in isolation/quarantine and waiting for a release to return to work?
- DO YOU HAVE ANY SYMPTOMS ASSOCIATED WITH COVID-19?
 - Visit [CDC.GOV](https://www.cdc.gov) for an updated list of COVID-19 symptoms
 - New Omicron variant symptoms include flu-like symptoms: dry coughs, fever, night sweats, body pains
- Have you been in CLOSE contact with an individual confirmed positive for COVID?

IF YOUR ANSWERS TO ANY OF THESE QUESTIONS ARE “YES,” please contact OMC at Ext. 3670

Brookhaven Lab Employee Daily Procedure during COVID-19

IF YOU FEEL SICK TODAY, PLEASE STAY HOME

Please review and take the following actions prior to leaving for work at the Lab site

1. Complete the Lab's online COVID-19 training course prior to returning to the Brookhaven Lab site for the first time.
2. Check your temperature every day ***before*** leaving for work. If your temperature is at or above 100°F, please contact the Occupational Medicine Clinic (OMC) at Ext. 3670 and speak to a nurse.
3. Review the questions on the reverse side of this card ***before*** leaving for work every day. If your answers to any of the questions are "YES," please contact OMC at Ext. 3670 ***before*** driving to work (if it's before 8 a.m., leave a voice message and an OMC nurse will return your call). Also, call your doctor if you have fever/symptoms. If you answer "NO" to ***all*** questions, please proceed to work.
4. Place this card with the "check mark" side up (other side) on your dashboard so that it can be seen by the officer at BNL's main gate when you pull your car up to the Security booth. For those without a card yet, you will be given one at the main gate after confirming with the officer that you have answered "NO" for that day to all questions.
5. Face coverings must be worn when entering any gate. You may be asked to pull the mask down for identification purposes.
6. Remember to wear your voluntary vaccination validation card on your lanyard.
7. If you feel any symptom(s) develop during the workday at the Lab, please place your work in a safe operating condition, go to your car, call OMC at Ext. 3670 and your supervisor immediately, and then leave site unless otherwise directed.
8. Please follow these recommended practices:
 - Maintain 6 feet of distance between you and others outside of your household members
 - Wear a face and nose covering while onsite and in public (e.g., visiting, shopping, and public transportation)
 - Wash your hands when arriving at work or at home
