As required, we have reviewed and approved the proposed Brookhaven National Laboratory's (BNL) Motor Vehicle Local Use Objectives (LUO) for FY 2016. The four vehicles (4) failing to meet their LUO for FY15 are approved. The justification provided continues use, per DOE Property Management Regulation 109-38.51-6(b) (3).

The Laboratory has shown great efforts to improve their LUO supporting documents. Also, monitoring underutilized vehicles this effort should continue to maintain a right-size fleet.

Also, approved for use are vehicles with no utilization standard, i.e. Emergency and law Enforcement and Special purpose per PMR 109-38.5103, (7) and 109-38.5104, for other equipment that has been reviewed and meet the programmatic requirements by the BNL Fleet Manager.
