The Department of Energy (DOE), Brookhaven Site Office (BHSO) hereby **approves** BSA's Personal Property Management System under DOE Contract Number DE-SC0012704 (Prime Contract), effective **November 30, 2022**. This approval removes the conditional approval from the October 12, 2021, Personal Property Management System approval.

In accordance with Prime Contract Clause I.162(i)(1)(i), BSA's Personal Property Management System "shall be maintained and administered in accordance with sound business practice, applicable Federal Property Management Regulations and Department of Energy Property Management Regulations, and such directives or instructions which the Contracting officer may from time to time prescribe." Effective **November 30, 2022**, DOE Order 580.1 from the DOE Directive List in Appendix I of the Prime Contract is no longer applicable. BSA must comply with Title 41 of the Code of Federal Regulation Chapter 109, *Department of Energy Personal Property Regulation*, and the provisions contained therein. The order will be removed in the next Prime contract update, following BHSO and BSA's Directive process.
