3. A memo will be distributed when possible.


The next film will be "Othello" starring Orson Welles on Thursday, March 1, in the Lecture Hall at 8:30 p.m.

THE BROOKHAVEN RECORDS CENTER

The preservation of permanently valuable records – as well as the disposition of other records once they reach the end of their usefulness – is a big task at an institution of Brookhaven's size and nature. This service, for the unclassified and declassified records of the Laboratory, is the responsibility of the Brookhaven Records Center, located at 68 Bell Avenue. The Center provides storage space for the records of all departments at Brookhaven, services the records, and sees that they are retained and disposed of in accordance with regulations. On its shelves can be found records of many different kinds from every department at the Laboratory including photographic negatives, inventory records and ledgers, Health Physics film badges, personnel records, purchase orders, scientists' research notebooks, engineering records – the list is a long one.

Any department finding its files overcrowded with material which must be kept but not often referred to may easily have the material removed to the Center. The transfer procedure is a simple one: the department simply telephones the Center, stating the number and size (letter or legal) of the material to be stored. Special transfer files are then sent to the department to insure the safe transport of the records. A records inventory form describing the material is made up by the department and accompanies the material to the Center. There, it is removed from the transfer file and stored, usually in metal


file drawers or heavy cardboard boxes. The filing system the department has used for the records is retained by the Center. The Record Center location of the material is recorded on the records inventory sheet and one copy of the form is then returned to the department. This facilitates quick access to the information in the future. A telephone request, specifying any information wanted from the records, is handled quickly by Center personnel. Only personnel authorized by the department from which the material has come are given access to the records.

All official records of the Laboratory – whether housed in the Record Center or located within departments – are subject to specific Records Retention and Disposition Schedules. It is the responsibility of the Records Center to see that files are kept or discarded in accordance with these schedules. If a department wishes the specified retention period modified for certain of its records, it must fill out a special form for approval by the proper authorities. In all cases a Certificate of Disposal is approved by the department before any records are discarded by the Center.

The growth of the Laboratory is reflected in the rapidly expanding size of the Records Center. Since 1951, storage has grown from 614 cubic feet to the 3,295 cubic feet now presently occupied. In 1960, the Center was moved from its crowded quarters in the bank building on Technology Street to the Bell Avenue location. The present building was chosen for the Center partly because of its cement floor, which is needed to support the extremely heavy weight of the stored material.
