## MOBILE ATOMIC EXHIBIT HERE

WEDNESDAY, DECEMBER 1, 1948

Brookhaven's "mobile atomic exhibit," which has been touring Connecticut and New York communities, will be brought home for a showing at the Laboratory itself, for the week beginning next Monday, November 6.

This exhibit was designed by Associated Universities, Inc., at the request of the Atomic Energy Commission, to help determine the value of exhibits as an educational tool in this field. The exhibit will be shown in the rear of the Research Staff Lounge from 11 a.m. to 3 p.m. each day, except for Thursday and Friday, when there will be 11 a.m. meetings in the Lounge. The exhibit will open those two days at 12:30 p.m.

The exhibit was designed in collaboration with numerous persons in the Laboratory, including K. P. Kallman, exhibit manager; John Garsield and George Cox, Division of Photography and Graphic Arts. Several members of the scientific staff served as technical advisors, including W. A. Higinbotham, Dr. Lyle B. Borst, Dr. Leslie Nims, Dr. R. A. Patterson, and others.

It is planned to take the exhibit to communities on Long Island for short showings just before and after the holidays, pending the Spring scheduling.

Since use of exhibits, by the Laboratory or by the Commission, is still in the experimental stage, it is particularly requested that suggestions for improving the exhibit be made by Brookhaven staff members to the Office of Public Education.

"We are interested in the opinions of technical people as to whether this exhibit presents a sound view of the field," said Michael Amrine, head of Public Education, "and we are interested in the opinions of non-technical peoples as to whether they feel this exhibit answers some of the questions most frequently asked about atomic energy."

To explain graphically basic facts of atomic energy, the exhibit includes among its feature displays:

--a block of uranium metal measuring only 2 x 2 x 5 inches but weighing 15 lbs. representing more refined uranium metal than existed in the entire world prior to the war.

--a life-size Geiger counter, operated by the visitors themselves, which demonstrates how atomic scientists using this instrument benefit. from radioactive isotopes in rescarch.

--a model of the atomsmashing Van de Graaff generator which propels at terrific velocities the particles used to bombard the nucleus of atoms.

--a sound movie which pictures some of the basic facts about atomic energy.

#### A UTOMOBILE INSURANCE

A number of automobile owner-drivers have asked "The Bulletin -Board" about whether their automobile liability insurance covers them in case of accidents which injure riders they are carrying to and from work on a ridesharing plan. This is a good question and we have tried to find a good answer.

The standard Automobile Liability and Property Damage policy issued to insure a private passenger car usually does not cover the owner in case of an accident occuring while the automobile is used for hire as a public livery or taxicab. During the war years, when ride-sharing plans were so common, insurance companies tended to overlook this exclusion in cases of ridesharing plans in which the riders only agreed to help the owner-driver share the expenses of driving to and from work. But when the driver charged a fare for carrying riders which was large enough to cover expenses and make him a profit too, the insurance companies frequently

ruled that the liability did not cover the riders.

Since the war the companies have tended to tighten up on ride-sharing plans somewhat. Where the idea is to share expenses and not to give the owner-driver a profit, the general rule is still that the insurance remains in force to cover riders.

But, of course, everyone wants to be sure about this. The only absolutely safe way of being sure is to get in touch with your own insurance broker, explainto him just what your ride-sharing plan is and


