## TABLE TENNIS FINALS

BNL's Table Tennis Tournament came to a fitting conclusion amid the applause of seventy-five enthusiastic onlookers. They had been treated to two exciting matches which saw S. Rottenberg successfully defend his singles title by whipping N. Porile and the defending doubles duo of S. Garrett and W. Lanyi meet defeat at the hands of H. Marshall and F. German.

The Singles was a victory for a sharp shot maker and adept defensive player over his aggressive, but less experienced opponent. The victory in four straight games adds to the BNL crown to Rottenberg's previously won Suffolk County Championship.

The Doubles pitted two closely matched teams in a series that went the full seven games. The tight play and prolonged volleying produced three deuce games before the final decision was reached.

Upon conclusion of the matches trophies were awarded by B.E.R.A. to the winning Doubles combination and the winner and runner-up in the Singles competition. —J. SADOFSKY

## TIAA - ANNUAL STATEMENTS

All employees participating in the A.U.I. Retirement Plan have received or will receive shortly an annual statement from T.I.A.A. showing the status of benefits accumulated as of December 31, 1958. This statement should be important to you. It represents a substantial amount of money contributed by you and the Laboratory into your retirement fund. It is your money. Do you understand the blue slip?

The blue slip you receive shows the accumulated benefits in T.I.A.A. ONLY and does not include your accumulation in C.R.E.F. If you are also participating in C.R.E.F. you will receive a report at a later date, since their fiscal year ends March 31st.

On the blue slip three sums are shown:

PREMIUMS (Column No. 2): This amount is the total of all contributions paid by you and the Laboratory into your retirement fund during the calendar year 1958.

TOTAL ANNUITY ALREADY PURCHASED (Column No. 4): The sum shown in this column is the amount you would receive each year, STARTING AT THE AGE OF 65 if no more contributions were made to the fund after December 31, 1958.

DEATH BENEFIT (Column No. 5): This sum is the total accumulation in your T.I.A.A. fund, based on the amount you and the Laboratory have contributed since the date you began participating in the plan, and includes all interest accumulated.
