NOTICE South Upton Road Detour

South Upton Road at the Moriches-Yaphank Road crossing will be closed beginning about April 18. A by-pass will be established so that **all** traffic from the East, South and West can continue to reach the Laboratory via Upton Road. **Follow the detour signs.**

To assist in relieving the traffic problem, the West Gate will be open from 0800 to 0900 Monday through Friday effective April 18 for traffic from the West and as usual from 1700 to 1720 for exit purposes.

On or about May 30, 1960, the new William Floyd Parkway will be open and at that time the West Gate will become the main entrance to the site and the North and South Entrances will be permanently closed.

FIFTH CONCERT Doktor and Puyana, Viola and Harpsichord

Tuesday, April 26th, Paul Doktor and Rafael Puyana will present the last concert of our current BERA series. This is Mr. Doktor's second appearance at Brookhaven. He was born in Vienna and took up residence in the United States in 1948. In 1949 he was invited to join the staff of the school of music of the University of Michigan. He left Ann Arbor in 1951 to devote himself entirely to a concert career.

Rafael Puyana came to Boston to study at the New England Conservatory of Music in 1950. In 1951 he was accepted as a pupil by Wanda Landowska and he is the only harpsichordist who is permitted to describe himself publicly as a "Landowska pupil". He made his Town Hall debut in April, 1957, and was acclaimed as being head and shoulders above the crop of young harpsichordists that appeared at that time.

As you see, it should be a fine concert. The program will be announced in next week's Bulletin Board. The concert will be in the Research Staff Lounge at 8:30 P.M. Tickets will be on sale at \$2.00 for adults and \$0.75 for children. All Laboratory employees and their friends are invited.



THE BNL PATENT OFFICE

Despite the fact that you cannot find it listed on any organization chart and most employees are unaware of its existence, the BNL Patent Office has been a part of the Laboratory almost since the day BNL opened for business. Probably everyone has seen the bright green and white sign in front of 56 Brookhaven Avenue, next door to the Personnel Office, and perhaps some have wondered if there is any connection between the BNL Patent Office and the New York Patent Group which the sign advertises.

The most obvious connection is that the two are congenial neighbors in the same building although the New York Patent Group is part of the New York Operations Office of the AEC, and the BNL Patent Office, as the name implies, is part of BNL. The BNL Patent Office is that function of the Director's Office charged with the responsibility of carrying out the Laboratory's contracted obligation to report to the AEC all discoveries and inventions made in connection with the work under the contract.

In the Interim Patent Agreement signed as a condition of employment by all BNL employees except clerical and others who do not have access to technical information, there is a statement which reads in part;

"that he will promptly disclose, report and communicate to the President of Associated Universities, Inc., or to such other person or persons as Associated Universities, Inc. may from time to time designate, full information concerning any and all inventions and discoveries pertaining or relating to, or arising from the work carried on by Associated Universities, Inc. or from the time of his association, assignment, access to facilities and receipt of information from Associated Universities, Inc. until the time of his leaving such employment or discontinuance of such work."

PATENT OFFICE (continued)

Stripped of its legalese, this statement means that the BNL Patent Office should be informed of any discoveries or inventions by members of the staff. The BNL Patent Office assists them in evaluating the patent significance of their work, preparing preliminary and formal patent disclosures, and performing liaison services with the New York Patent Group. At present the office is a oneman, one-girl operation.

Keeping track of developments in as large a research organization as this Laboratory, with its wide diversity of research programs, is difficult and a variety of methods have been developed to guarantee a reasonable chance of uncovering reportable discoveries and inventions. First, the office is helped in its work by department representatives appointed by the Chairmen of the various departments to guide the BNL Patent Office to areas of work having possible patent interest. Also, the Information Division, as part of its prepublication routine, submits all scientific papers, abstracts, and BNL numbered reports to the BNL Patent Office for patent clearance prior to release for publication.

As a third source of information, part of the termination clearance procedure is an interview of all individuals having access to technical information by the BNL Patent Office before departure. In addition to these established procedures, early notification of possible discoveries and inventions by the individual research staff members is encouraged to avoid delays in publication of papers.

For those who are interested in statistical tabulations, the BNL Patent Office each year reviews on the average 600 papers, abstracts and reports, prepares 70 preliminary patent disclosures and 20 formal patent disclosures, resulting in about 6 patent applications filed by the AEC each year. While the patents play only a minor role in the Laboratory's whole program, the Laboratory has a definite contractual obligation to make timely disclosures of any discoveries and inventions.

These can come from any of the Laboratory's varied research programs any time and run the gamut from new vegatatively propagated plant species, activity cages for laboratory animals, hot-lab manipulators, accelerator designs, and meteorology equipment, to the multitude of new electronic instrumentation developments utilizing transistors, diodes, and vacuum tubes.

COSMOTRON SHUT DOWN FOR REPAIRS

On Friday, April 1, 1960, a short circuit occurred in the stator windings of the large generator which supplies power to the Cosmotron magnet. The arcing was the result of an as yet unexplained failure of the electrical insulation. There was considerable damage to the copper windings and a lesser amount to the iron core. Westinghouse is now removing the old coil and repairing the iron core preparatory to installing a complete new coil. The repair will take two months to effect.
