#### RICHARD III

On Monday, February 6, the BERA Film Study Group will present Laurence Olivier's color production of Richard III based on the play by William Shakespeare. TIME Magazine said of the film, "The cast that Olivier has assembled is a 'Who's Who' of the British theatre -Sir John Gielgud, Sir Ralph Richardson, Sir Cedric Hardwicke, Claire Bloom, Pamela Brown – and they play, for the most part, with a remarkably even and deep-breathing power. Olivier himself interprets the title role with a mastery so complete that Richard III in this generation can surely never be himself again.



Newsweek called it "the year's most exciting film." The dark history of a wicked king - an interwoven pattern of literature, history and legend - springs to exciting life on the screen. Here are pageantry and social portraiture, all the political elements that made possible a hunchbacked king's career of brutality and crime in medieval England. Here is soaringly loveliness of speech, image, costume, setting. Above all, here is the genius of Shakespeare interpreted by one of the most magnificent casts of actors ever assembled for a film, directed by the most superb Shakespearean of our generation.



## AGS EAST EXPERIMENTAL BUILDING UNDER CONSTRUCTION

A 60,000 square foot experimental building is under construction at the Alternating Gradient Synchrotron. The 458  $\times$  166 foot building is being constructed in an L-shape around the existing Target Building. It is expected that the new facility will be completed in July, 1961. The framework has been erected, and the installation of the walls of insulated aluminum panels and the roof is almost complete.

Malan Construction Corporation is the general contractor. Stone and Webster Engineering Corporation designed the building and is supervising its construction. The structural steel was fabricated and erected by the American Bridge Division of the U.S. Steel Corporation.



Six years ago, when the existing Experimental Area was laid out, it was thought that a large number of experiments could be performed in small isolated movable houses scattered outside the Target Building. Since then, technological developments have resulted in experiments which require beam layouts up to several hundred feet in length, containing large numbers of analyzing, bending, and focusing magnets, electrostatic beam separators, vast arrays of counters, and very large bubble chambers. These developments, plus the requirement of rapid movement of experimental set-ups, dictated that the new areas be covered by overhead traveling cranes and that they be enclosed with a weather shell.

The huge new building will consist of one 56' high main room. Within this will be a two story structure containing an operations office and rest room on the first floor, and a control room on the second floor which overlooks the experimental area. This control room will contain various alarms, timing and control circuits and equipment. To indicate the large scale of the new building, when one of the two forty-ton overhead cranes (now installed in place) was being shipped to BNL, it had to be carried on three railroad cars because of its 96 foot length.

The electrical services will be carried in ladder-type racks along the wall of the building. Electric power will consist of very heavy 480 volt power for particle beam analyzing and focusing magnets, and 120/208 volt power for minor power requirements.



#### **AGS East Experimental Building - continued**

Services will also include piping for experimental magnet cooling water systems, a high pressure helium system for bubble chamber operations, compressed air, and domestic water. Among protective features to make the building safe for experimental work with liquid hydrogen and other potentially dangerous materials will be special air and gas vents, combustible gas alarms, and thirty special high capacity roof fans and automatic air intake louvres.

The existing target building contains 25,200 square feet. When the East Experimental Building is completed there will be approximately 85,000 square feet of experimental area at the AGS, compared to 18,700 square feet in the recently enlarged facilities at the Cosmotron. In addition, excavation has been completed for the Bubble Chamber House, and the contractor who will build the concrete foundations and blast walls is now at work. The Bubble Chamber House will house the 80-Inch Bubble Chamber which is now being fabricated (January 17, 1961 BULLETIN BOARD). This building will be located north of the AGS just off Fifth Avenue.


