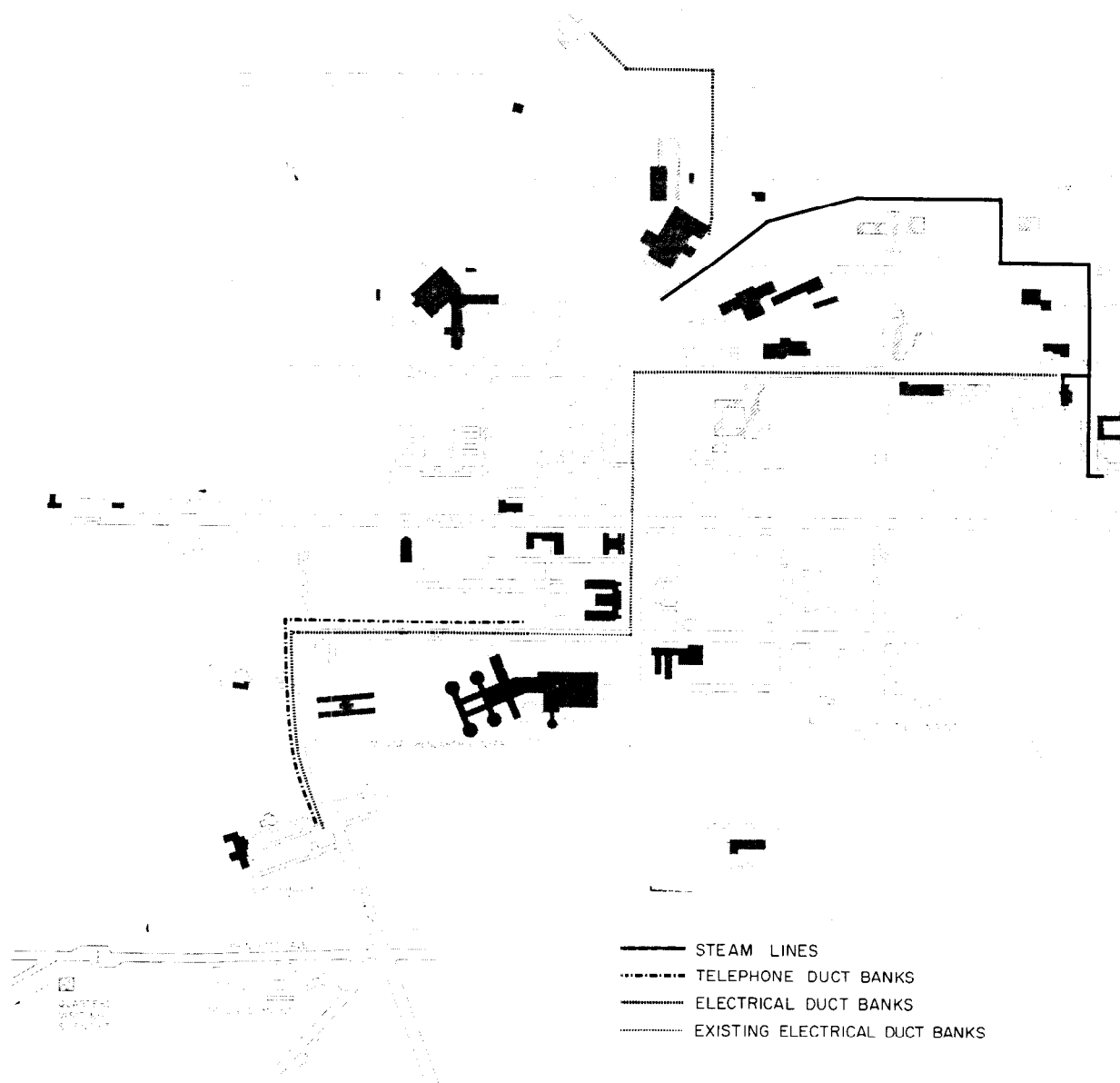

DIG WE MUST

You have undoubtedly noticed the excavations along the north side of Cornell Avenue between the Cyclotron and the Metallurgy Building, and the stacks of conduit along Upton Road near the Brookhaven Center. These are all part of the underground utility improvement program made necessary by the fast pace of construction of new buildings and research machines. For the next several months, motorists on site may be somewhat inconvenienced where digging is carried on along roads and at intersections.

Dig We Must - (Contd.)

In general terms the improvement program will provide electrical power and steam for buildings presently under construction as well as for future buildings now in the planning stage, and will include improvements which will both minimize and localize shutdowns in case of breakdown in any part of the systems.

Additional electrical power capacity is being provided by the addition of a 30,000 kva transformer in the substation, more than doubling its capacity. Electrical power will be distributed in new underground ductbanks, including new manholes, in the following areas: 1) from the substation west along Cornell Avenue to Center Street where connection will be made to existing ductbanks, 2) from existing banks at the A.G.S. north then west to the Bubble Chamber House and 3) from existing banks on Bell Avenue opposite the Medical Research Center west to Upton Road, then south along Upton Road to a point near the Brookhaven Center where connection will be made to existing banks serving the Apartment Area.

Expansion of the steam distribution systems consists of adding a new 60,000 lb. per hour boiler at the Central Steam Plant (Bldg. 610) and installing new underground steam supply and condensate return piping together with the necessary manholes and connections in the following areas: 1) from the Steam Plant east to Sixth Street then south to the Critical Experiment Facility, and north then west to the Volatility Studies Laboratory and the High Intensity Radiation Development Laboratory where a connection will be made to the existing steam line on Railroad Street, and 2) from Railroad Street and Fourth Avenue west along Fourth Avenue then southwest to the existing line midway between the Reactor and AGS.

This work will be going on during the Summer and will be substantially completed in the early Fall.

SOCIAL SECURITY

Some married women still carry the same social security cards they had before they were wed. They fail to make the necessary changes for months, or even years, after they have changed their names from Miss to Mrs.

The key to your social security record is your social security account number card. No one should have more than one social security number, yet it is possible to have more than one card under different names. In the interest of having all earnings properly credited to the proper account number, the Social Security Administration needs to know about changes in names, whether it be because of marriage, divorce, or other reasons. Women who marry and fail to report this change may experience delay when it is time to figure the social security benefits due them.

It really is a simple matter for a newly married woman to insure that her social security records are current and correct under the proper name and number. If you can, it is best to bring your old social security card to the nearest social security office. In Patchogue the address is 38 Oak Street - G.Rover 5-3031. The social security office will issue you a new card with the same account number you had but under your new name.

BNL BRIDGE CHAMPIONS

BNL's newly formed bridge team registered a handy first place finish over thirty-three other teams in the Industrial Bridge League team-of-four championship. The two-session event took place Wednesday and Friday evenings in New York City.

Other competitors included IBM, Bell Laboratories, Standard Oil (N.J.), Republic Aviation, Metropolitan Life, Equitable Life, Hazeltine, American Cyanamid, Prudential Life and other top industrial teams.

Les Lawrence, Sandy Wagner and Haskell Frei, the three members of the five man team to play all of both sessions, sparked the winners with some imaginative bidding and good card play. Also on the team were Mary Anne Kelley and Jake Tillinger.

When Wagner and Lawrence met this hand as E-W their team was down 100 points as their team mates had gone two tricks at a three heart contract with the N-S cards. The bidding here was highly competitive. When Wagner's speculative 2NT bid was doubled, Lawrence ran out to three clubs. South competed with three diamonds. Wagner, feeling that three diamonds would be made and thinking that his partner was very possibly void in diamonds, competed with four clubs. Lawrence lost two hearts and a club, the 130 score winning the board for Brookhaven.

Brookhaven Laboratory and Grumman Aircraft will be sent by the American Contract Bridge League to the Summer Nationals in Washington, D.C. to play against industrial teams from throughout the country for the National Industrial League championship.

Two Have Accidents at Work

Two employees suffered lost time injuries since the last report in THE BULLETIN BOARD.

The first was a Plant Maintenance employee, who was cutting grass with a rotary mower. Approximately 20 feet away was another mower of the same type which threw a small piece of wire out of the discharge and into the leg of the injured employee. The surgical removal of the wire has required lost time which is continuing at this time.

The second injury involved an employee at AGS when a floor plate tipped and caused a fall into a trench. About one week of lost time resulted. The plates have now been bolted to the floor to prevent further repetition.

We have now had five lost time accidents in five months of this year. In 1959 there were 12 and in 1960 there were 8 lost time accidents at the end of May.
