AWARD PRESENTED TO BNL RESERVISTS

Dr. James H. Wakelin, Jr., Assistant Secretary of the Navy for Research and Development, presented the Navy's A. Hoyt Taylor Award to Naval Reserve Research Company 3-9 during a simple ceremony last Wednesday evening at the Brookhaven Center. The award, in the form of a handsome bronze plaque, was presented to the company after a reception and dinner attended by the members and their families and distinguished guests from the Navy and BNL.

Dr. Wakelin, in his remarks, congratulated the BNL reservists for being

the first to win the award in competition with over a hundred other Research Reserve Companies. The award is named after Dr. A. Hoyt Taylor, a former reserve officer and naval scientist who pioneered in the development of radar. It is given, as Dr. Wakelin pointed out, only in recognition of outstanding scientific work by a Research Reserve Company.

The award was presented to "Three Dash Nine" for its work on a scientific study entitled "An Evaluation of the Need for Filtration Systems for Protection of Personnel in Structures against the Acute Hazards of Radioactive Contamination of the Atmosphere". It will be published shortly as a Naval Research Report.



NO FENCING THIS WEEK


Since the Gymnasium will be closed on Wednesday, there will not be a meeting of the Fencing Club this week.
