# PAYROLL PROCEDURES FOR MEMORIAL DAY HOLIDAY

Memorial Day, Wednesday, May 30, 1962, will be observed as a Laboratory holiday.

All weekly time cards **must** be delivered to Payroll by 10:00 a.m. on Monday, May 28, in order to have the weekly checks ready by Friday, June 1. 


The Stan Laurence band promises some good music. They are five versatile fellows and will please everyone's taste in music.

### CHILDREN'S SUMMER PROGRAM

Once again our Recreation Program will feature a "Summer Program" for children of laboratory employees. The supervision will be provided by two experienced instructors.

## TIAA - CREF

Participants in the Laboratory Retirement Plan may elect to have all premiums applied to TIAA, the fixed annuity, or may elect to have a percentage of premiums applied to TIAA and the remainder (up to 50%) to CREF, the variable annuity.

These percentages may be changed once a year, effective July 1. All participants who wish to change current percentages must make application at the Personnel Office prior to June 1, 1962.

### NON-TAXABLE SICK LEAVE

The Internal Revenue Code of 1954 provides that payments made to employees for sick leave under the Laboratory sick leave policy may under certain circumstances be excluded from gross income for Federal income tax and Social Security purposes. Payments received under the following circumstances may be excluded:

- 1. If absence from work is caused by sickness extending beyond seven consecutive calendar days, sick leave payments up to a weekly rate of \$100 attributable to the eighth and all consecutive days of absence thereafter may be excluded from gross income.
- 2. If absence from work is caused by sickness, and the employee is hospitalized for one or more days during that absence, sick leave payments up to a weekly rate of \$100 attributable to the first day of absence thereafter may be excluded from gross income.
- 3. If absence from work is caused by **personal injury** (either occupational or non-occupational), sick leave payments up to a weekly rate of \$100 attributable to the first day of absence and all consecutive days of absence thereafter may be excluded from gross income.

Any employee who has sick leave payments during 1962 which fall in one or more of the above three categories should fill out Form No. 989-A, obtained through your Department, immediately after the illness and return the form to the Payroll Section. It is important to note that Form 989-A SHOULD BE COMPLETED UPON THE EMPLOYEE'S RETURN TO WORK so the information can be reported on the W-2 form next year. If you fail to report non-taxable sick leave at the time it occurs, it will be assumed that the sick leave payments are taxable.

If an employee elects to use vacation leave to provide wages while absent because of illness or injury, vacation pay may be considered in computing the amount of sick pay exclusion.

# TO THE OWNERS OF SMALL CRAFT

The Supervisor of New York Harbor, Department of the Army, had this to say to the owners of small craft in a recent notice.

Parties on small craft frequently dispose of refuse by throwing it overboard into Long Island Sound, Great South Bay, etc. All refuse should be collected on board and carried ashore for disposal. While the amount of garbage collected on your own boat may be small, the total quantity from the thousands of boats using these waters creates a major and serious problem. It actually constitutes a considerable menace to the healthfulness and general cleanliness of the waters and the bordering beaches.

The practice of disposing of refuse overboard is forbidden by Federal Statutes, which make it a misdemeanor punishable by a fine and/or imprisonment. All are requested to cooperate in keeping navigable waters clean.
