### NEW CHEMISTRY BUILDING STARTED

Ground was broken last Tuesday afternoon, February 19, for the new Chemistry Building. The ground-breaking was performed by Dr. R.W. Dodson, Chairman of the Chemistry Department. The ceremony was initiated by brief talks by Mr. E.L. Van Horn, Manager of the Brookhaven Office of the A.E.C.; Dr. Gerald F. Tape, President of A.U.I.; Dr. Clarke Williams, Deputy Director of the Laboratory, Mr. Roland A. Wank, representing the architect firm, and Dr. Dodson.

The building will be constructed in the area bounded by Center Street, Johns Hopkins Avenue, Herschel Place and Cornell Avenue, at a cost of approximately \$6,000,000. The three-story, cross-shaped building, which will consist of 138,000 square feet, will house 51 offices, 71 laboratories, several counting rooms, shops, a conference room, and a library. A seminar room is architecturally featured as a separate free form adjoining the front of the building.

The contract for the construction of the initial phase, or shell, has been awarded by the U.S. Atomic Energy Commission to the White Construction Company. The architects are Fellheimer & Wagner, and the engineers are Vitro Engineering Company. It is estimated that the new building will be ready for occupancy in 1965.



Employees are urged to follow the "Ticket Practices" outlined below so that the box can be enjoyed by as many people as possible.

#### TICKET PRACTICES

- 1. The Recreation Office will be open for ticket sales and information daily 9:00 a.m. to 1:00 p.m.
- Tickets are intended for the employee and members of his immediate family. It is understood a single employee might wish to purchase an additional ticket for his or her escort.
- 3. Employees may purchase either 2 or 4 tickets.
- 4. Tickets will not be sold to any one employee for more than 2 games in advance.\* An employee who has purchased tickets for 2 games in advance will be permitted to buy additional tickets only after he has attended at least one of his games. In other words, tickets will not be sold to anyone currently in possession of tickets for 2 unplayed games.
- 5. Tickets will not be returnable or acceptable for refund at the Recreation Office.
- If a game is rained out or postponed, refund or exchange should be made at the Ticket Office at the Ball Park.

#### SCOTCH DOUBLES BOWLING TOURNAMENT

A Scotch Doubles Bowling Tournament is set for 3:00 p.m. Saturday, March 30, at the Port Jeff Bowl. A maximum of 64 teams can participate, so sign up early to make sure you don't get left out.

#### The Rules:

- 1. A team shall consist of two bowlers, one male and one female. At least one member of each team must be a BNL employee (per BERA definition). Anyone who has bowled 12 or more games in any organized league from September 1961 to March 1963 is eligible.
- 2. The tournament shall consist of 4 games per team, bowled across two pairs of lanes. Each team will bowl a single score for each game with the **team members** alternating balls rolled. The first ball to start each game will be rolled by the **female** member of the team.
- 3. Team handicap shall be arrived at by averaging the two bowlers handicaps which were calculated per regular season B.N.L. League rules (80% of the difference between bowler's average and 200).
  - a. Bowlers in BNL League this season use BNL average as of March 1, 1963.
  - Bowlers not in BNL Leagues this season, use highest current league average as of March 1, 1963.
  - c. Bowlers without current averages, some earlier averages may be used, check with Recreation Office or Tournament Committee for applicable rules.
- 4. Prizes will be based on gross team scores and awards given as follows:
  - 1st Place Team, 4 game series Two trophies and 6 bottles of Scotch.
  - 2nd Place Team, 4 game series Two trophies and 4 bottles of Scotch.
  - 3rd Place Team, 4 game series Two trophies and 2 bottles of Scotch.
  - 1st Team High Gross game Two trophies.
  - 2nd Team High Gross game Two trophies.
  - 3rd Team High Gross game Two trophies.

The above prizes are guaranteed for the minimum of 40 entries. Additional prizes will be awarded based upon the number of team entries in excess of 40. No ABC or WIBC prizes.

- 5. Team entry fee, including the cost of bowling, is \$4.50. Entry blank and fee must be presented at the Recreation Office not later than 3:00 p.m. on Friday, March 22. **No entries** will be accepted **after** the first **64** have been received. The fee is non-refundable; only in the even that the minimum number of team entries (30) is not reached will the fee be refunded and the tournament called off. Teams not present and ready to bowl at the start of the tournament will forfeit the team fee.
- 6. The rules fo the BNL Bowling Association are adopted for this tournament except as otherwise stated herein.
- 7. Decisions of the Tournament Committee shall be final.
