Walter Kato to Be Honored by Japan

In just four days, Walter Kato, a BNL Senior Scientist and former Chairman of the Department of Nuclear Energy (DNE), will be awarded a medal from the Japanese government for his contributions to nuclear safety and nuclear engineering education in Japan. The medal, Kun-Santou Zuiho-sho, is translated as the Order of the Sacred Treasure, Gold Rays with Neck Ribbon.

Kato and his wife, Anna will attend an awards ceremony in Japan on March 16 courtesy of the Japanese research institutes that he has worked with over the past 35 years. He is one of 44 foreigners from 15 countries who will be receiving awards for distinguished service from the Japanese government and one of two foreign scientists to be honored within the top three ranks of eight classes of awards.

Commenting on his award, Kato said, "I am a strong proponent of international collaboration in

nuclear safety. While at Brookhaven, I've worked with European, Russian and Chinese, as well as Japanese scientists, on this issue. All of us in the nuclear field realize that a serious accident anywhere would have profound effects throughout the world. so it is necessary to work together and to give top priority to nuclear safety issues."

Kato first came to the Lab in 1952 as a student from Pennsylvania State University, to work on his graduate thesis. He received his Ph.D. in physics in 1954. From 1953 to 1975, Kato worked in reactor physics and safety at Argonne National Laboratory. He returned to BNL in 1975 as Associate Chairman of the Department of Applied Science, and he advanced steadily in his career, eventually becoming DNE Chairman.

Kato's work with Japan began in 1958-59, when, as a Fulbright Fellowship scholar, he was a research professor at the Japan Atomic Energy Research Institute (JAERI) and a lecturer in the Department of Nuclear Engineering at the University of Tokyo. During this period, he contributed to the design of reactor

physics critical experiments at JAERI and the Hitachi Central Research Laboratory. While at Argonne, Kato collaborated with Japanese researchers on reactor physics experiments over several years.

Kato also developed a cooperative program between the Nuclear Power Engineering Center of Japan and BNL to do high-level vibrational testing of large diameter piping in pressurized water reactors. This program, which was jointly sponsored by Japan's Ministry of International Trade and Industry, the U.S. Nuclear Regulatory Commission, and the Electric Power Research Institute, studied the seismic effects on reactor piping.

Kato is now a member of the Independent Review Panel of the Long Island Power Authority on the decommissioning of the Shoreham Nuclear Power Station. He is a fellow of the American Nuclear Society and currently serves on its board of directors. Previously, he was a consultant to the U.S. Nuclear Regulatory Commission's Office of Nuclear Regulatory Research.

Menopause is the time in a woman's life when her monthly ovulatory cycle gears down until she no longer menstruates. While this is the most obvious sign, there are other changes - physiological, emotional and sociological — that take place during this

From the turn of the century until the early '70s only five studies of the most common menopausal sympton, hot flashes, were reported in the medical literature. In the past, many physicians chalked up all climacteric women's symptoms to estrogen deficiency or dismissed women with severe menopausal problems as neurotic.

To present the latest findings in the medical understanding of menopause, physiologist Fredi Kronenberg will offer an "Update on Meno-

pause," as the next Healthline lecture. Sponsored by the Health Promotion Program of

the Occupational Medicine Clinic, Kronenberg's talk will take place on Tuesday, March 16, from noon to 1 p.m. in Room B, Berkner Hall. All

As Kronenberg will discuss, the goal of her last 12 years of research has been to understand the physiological causes of hot flashes, to find more effective ways to make women more comfortable during menopause. She will explain how the body's thermoregulatory, nervous and hormonal systems interact to initiate changes that hallmark menopause, and outline trends in alternative approaches to treatment.

An assistant professor at Columbia University Medical Center, Kronenberg is founder and member of the board of the North American Menopause Society. She is on the editorial board of Menopause Management. and is involved in establishing a new research journal called Menopause.

She has also established the Women's Association for Research in Menopause.
