1. Attendance

3. Administrative Items

The meeting was called to order at 6:30 pm. Michael White, facilitator, welcomed everyone to the meeting. He reviewed the ground rules and draft agenda and those present introduced themselves.

Member Ziems said he would be interested in a presentation on Solar Energy.

Approval of Minutes

The March notes were approved as written with none opposed and two abstentions.

4. Groundwater Update, Bill Dorsch, Manager – Groundwater Protection Group

Dorsch spoke about modifications to the Western South Boundary Treatment system. He said modification designs will be submitted to the regulators at the end of May for four new pump and treat extraction wells. Construction is expected to begin in June and they should be operational in September.

Member Krupski asked how much water will being pumped through the four additional extraction wells.

Dorsch said each well pumps about 75-100 gallons per minute, so a total of 300-400 gallons per minute in total for the four wells.

Dorsch said Ethylene Dibromide (EDB) concentrations in well 000-394 remains above drinking water standards, so seven new temporary vertical profile wells have been installed. We are continuing to characterize the extent of EDB in this area.

Member Krupski asked what the source is.

Dorsch said we do not know. We are drilling down into the clay area and sampling every 10 feet.

Member Bowerman asked where these wells will be located.

Dorsch said it is part of the AVR property; we have paid for leasing rights on AVR property.

White asked if this affects the water supply in that area.

Dorsch said no, this whole area will be connected to Suffolk county water.

He said testing in 2017 detected Perfluorinated Compounds (PFCs) in three of BNL's potable supply wells. Several possible sources from the 70's and 80's have been identified. A plan is being submitted to the regulators for temporary wells to be installed to determine distribution of PFCs.

Dorsch then spoke about the remaining soil remediation at the Former Waste Concentration Facility. Demo and soil cleanup was completed in 2016 to help reduce the environmental liability risk to soil and groundwater. Cs-137 was the primary contaminant in the soil. A closeout report was submitted to the regulators in October 2016 documenting that the cleanup goals were met. One area of surficial contamination north of the excavation area that was not in the original scope remains and is currently radiologically posted and under institutional controls. He said planning is underway to excavate the remaining areas exceeding the residential cleanup goal of 12 pCi/g for Cs-137. Excavation and disposal is planned for this summer and there are plans for a parking area/cap once cleanup is completed.

Member Esposito asked what the depth to groundwater is.

Dorsch said 25-30 feet.

Member Ziems asked where the contaminated soil will go.

Dorsch said Energy Solutions in Utah.

Member Esposito asked how much soil will be removed.

Remien said about 370 cubic feet.

5. Agenda Setting

Nora Sundin said George Clark, Brookhaven Lab CFO, will present on doing business at BNL at the June CAC meeting. There will be a quick update on the prescribed burns planned for onsite by Kathy Schwager. We would also like to have a discussion with members on how we can improve the CAC moving forward. We are looking for your input. Then in September, we will have a 20 year anniversary celebration for the CAC. I will be sending out a Save the Date.

6. Nonproliferation and National Security programs at BNL, Susan Pepper – Chair, Nonproliferation and National Security Division

Susan Pepper spoke about nuclear safeguards, which are the activities undertaken to account for and control nuclear material. She said the definition of nonproliferation is preventing the increase of weapons.

Pepper said the IAEA (International Atomic Energy Agency) was established in 1957 to promote the peaceful use of nuclear power and prevent the spread of nuclear weapons. There are currently about 180 member states providing financial support. It is a monitoring agency that reports to the United Nations Security Council. She then spoke about the NPT (Treaty on Nonproliferation of Nuclear Weapons) which entered into force in 1970 to enable the IAEA to perform comprehensive safeguards inspections and establish nuclear weapons states and non-nuclear weapons states. The event on September 11, 2001 increased attention on US borders and domestic security. As a result, the US created the Department of Homeland Security to centralize domestic security efforts.

Member Esposito asked how you can tell if a country has exceeded the allowable limit for nuclear power.

Pepper said the IAEA can take samples and measurements during unannounced inspections.

White asked for comments from the community. There were none.
