#### 3. Administrative Items

The meeting began at 6:35 p.m. Reed Hodgin, facilitator, reviewed the ground rules and the agenda. Those in attendance introduced themselves.

#### Approval of Minutes

Quorum was not met, so there was no approval of minutes.

## 4. Update on status of HFBR stack removal, John Sattler, DOE

John Sattler, Department of Energy Federal Project Director - Office of Environmental Management, told the CAC that a decision was made to stop work on the HFBR stack removal project. He said that the contractor has been instructed to demobilize, but the work is still

expected to be completed this fiscal year. BSA is going to self-perform the decommissioning of the silencer inside the stack, which is where the bulk of the contamination is located.

Member Sprintzen asked why this is being done and if the contractor will come back in the spring.

Sattler said the project has been delayed, which increases cost, so a decision was made to stop and move forward with the self-performance of the silencer. As the work began, it was discovered that the design of the structure was different than originally believed. It has been his experience working on decommissioning projects on DOE sites, that it is not uncommon to find out that real conditions are different from the design. The weather and safety concerns were also factors in delaying the project. It is not known at this time whether or not the contractor will be asked to come back.

Member Corarrino asked if this project is solely funded by ARRA dollars, if that money can be rolled over into next year, and when a decision will be made.

Sattler said yes, it is ARRA funding; however, we should still have the money to complete it this year. It can be rolled over if necessary. A decision should be made in the next month or two.

Member Heil asked how big the silencer project is and if robots will be used.

Tom Jernigan, Director, Environmental Restoration Projects, said there are 32 - 10' X 20' panels inside the concrete structure. The work will all be done inside a containment structure, so it will not be necessary to use robots.

Reed asked the CAC if they would like to continue to receive updates on the status of this project.

The CAC said they would.

#### 5. Environmental Restoration Projects FY10 Performance, Charles Schaefer, ERP

Charles Schaefer explained the Environmental Restoration Projects' annual planning process and FY10 objectives and targets. He spoke about environmental performance, pollution prevention and safety performance. He said that the BGRR Graphite Pile has been removed, the HFBR stabilized, and the Bldg. 704 fan house has been demolished. He also said that there have been zero OSHA lost work day cases, no radiological events, and Pollution Prevention initiatives have been achieved. He said that there were more than usual reportable spills in FY10 because of the use of outdoor heavy equipment onsite. He said they were all small spills of less than one gallon each. All spills of a petroleum product or a hazardous material to the soil or the environment must be reported. He said there were two reportable ORPS (Occurrence Reporting and Processing System) events, neither one resulting in injury. He then gave the CAC a look ahead to FY11 goals and objectives.

Member Graves asked if vegetable oil is used in a hydraulic line and there is a spill, is that reportable?

Schaefer said he didn't think so, but will find out and get back to him.

ACTION ITEM: Find out if a vegetable oil spill from a hydraulic line is reportable.

#### 6. Agenda Setting

Nora Detweiler, liaison to the CAC, said next month Sam Aronson, Lab Director, will give a

presentation on the Lab's 10-year strategic plan. The presentation on the Environmental Assessment for the modifications to the STP discharge will be either next month or the following month. She apologized that the scheduled tours of the Peconic River were cancelled due to the weather. She also said there will be an agenda setting exercise next month and asked everyone to write their topics on the flip charts at the front of the room. A list will be compiled and sent out to all members and that it will be prioritized at next month's meeting.

#### 7. Community Comment

Margaret Malloy's request for memberships was postponed until next month due to the fact that quorum was not met.

There was no community comment.

# 8. Meeting the Challenge of Reducing Greenhouse Gas Emissions in NYS – The NYS 80 By 50 Plan, J. Patrick Looney, Chair, Sustainable Energy Technologies, BNL

Pat Looney discussed sustainable energy research at BNL, climate change and energy, and the New York State Climate Action Plan and BNL's role. He explained Brookhaven's Energy Research Plan and said that Sustainable Energy Technologies is a new department at the Lab that has been in existence since October 1, 2010. He said the strategic focus is in making the transition from the discovery to deployment. Our mission is to identify and overcome barriers, whether they are scientific, technical or policy related to the adoption and deployment of sustainable energy technologies. We are also interested in conceptualizing and developing new approaches and solutions for Brookhaven discoveries. We hope to partner with other organizations across the Laboratory, New York State, and the Country. He said that BNL's energy vision is for the effective use of renewable energy through approved conversion, transmission, and storage.

Member Heil asked for a definition of sustainable.

Looney said his definition is; "Do not limit the options of future generations". He explained the NYS Climate Action Plan. In 2009, Governor Paterson signed an Executive Order asking the State to reduce greenhouse gas emissions from all sources within the state to a level 80% below the 1990 level by the year 2050. This is called the NYS 80 by 50 Plan. Brookhaven contributed one chapter to the plan which is available in draft form on the web at <a href="http://www.nyclimatechange.us/">http://www.nyclimatechange.us/</a>. The 1990 level for CO<sub>2</sub> emissions was 277 million metric tons. The goal is 55 million metric tons by the year 2050. The United States is a leader on environmental policy and New York State is always out in front.

Member Sprintzen raised a question about whether the 80 by 50 plan assumed current rates of growth in energy demand and questioned the extent to which such an assumption biased the presentation of the alternative scenarios.

Member Graves asked how that goal was developed.

Looney said it is thought that it will help stabilize the temperature. He spoke about global warming, climate change, U.S. energy use, world-wide energy demand, and New York State's carbon footprint. He also discussed what it will take to meet the challenge.

Member Esposito said good science is the foundation for good policy. She said she would hope this work can be incorporated into the states' planning process.

Member Heil asked how big this new department at BNL is and what it consists of.

Sam Aronson, Lab Director, said this is a good lead into next month's presentation on the Lab's strategic vision. We hope to expand our impact through deployment.

Looney asked anyone with additional questions to email him directly.
