#### 3. Administrative Items

The meeting was called to order at 6:35 PM. Reed Hodgin, facilitator, reviewed the ground rules and the agenda. Those in attendance introduced themselves.

#### Agenda changes

The environmental update was removed from the agenda. It will be presented at next month's meeting. The discussion on membership was moved to follow the science presentation.

Dr. Robert Tribble, BNL Deputy Director for Science and Technology, announced that Peter Genzer will be serving as Interim Assistant Laboratory Director for Community, Education, Government, and Public Affairs.

Genzer said he has been at the Lab since 1996. He has been to many CAC meetings over the years and looks forward to working with them.

Nora Sundin, liaison to the CAC, showed the movie trailer to *Particle Fever* and invited everyone to attend the screening at the Huntington Cinema Arts Centre on May 18<sup>th</sup> at 2 PM.

Hodgin said this is an International event that Brookhaven Lab is part of.

#### Approval of Minutes

Hodgin asked for corrections, additions, or deletions to the April 10, 2014 draft notes. The notes were approved as written with none opposed and three abstentions.

## 4. Advances in Accelerator Science Deliver Precision Beams for Cancer Therapy, Steve Peggs, physicist and Stony Brook University adjunct professor

Steve Peggs described the characteristics of x-rays and protons. He said x-rays are photons and have only one collision, stopping at a spread of ranges. Protons (ions) have many collisions, which all stop at about the same range. Protons can be steered left/right or up/down with magnets. He showed the difference between dose received from x-rays and from protons. The goal is to irradiate a tumor without irradiating the surrounding healthy tissue. He explained Brookhaven's role and said carbon ions are smaller and cheaper and that North America has fallen behind in the trend towards carbon/ion therapy.

Member Ziems asked why North America is behind. Is it funding, politics, or legislation?

Peggs said it's all three, but funding is always an issue. We need to get the National Institute of Health to work with the Department of Energy.

Member Chaudhry asked about carbon ion treatment.

Peggs said carbon is more effective than protons because it kills double strand DNA cells in two places instead of one.

Member Martin asked if the carbon does more damage on the way in.

Peggs said no, it actually does less damage than protons.

Member Shea asked if there have been a lot of animal and primate studies. She also asked if the damage from the treatments is cumulative.

Peggs said the only place that primate studies are done, to his knowledge, is in Washington, DC at the Walter Reed facility. Typically, the treatments kill cancer tissue and healthy tissue. The healthy tissue regenerates at a faster rate than the cancer, so it's a race to kill the cancer cells before they regenerate, while allowing the healthy ones to regenerate.

Member Blumer asked if there is a cost difference between carbon and proton.

Peggs said carbon is harder to bend, so therefore, it is more expensive than protons.

Member Malloy asked if Japan is the leading country with accelerators.

Peggs said, yes, the regional government is funding it.

An audience member asked if there have been any efforts to treat lung cancer with protons.

Peggs replied there is research funded by the Army on lung and breast cancer. There is a need to steer the beam with the breathing cycle, especially in lung cancer. I am not aware of any clinical trials.

Tribble said in a facility in Japan, they are building a new wing with real time ways to track a patient's breathing and movement and to monitor where the beam goes.

Member Blumer asked how this work is funded. Is this fundamental research or applied research?

Peggs said there are three or four patents on various aspects of the design. He said his work is funded partially by Best Medical through a cooperative research and development agreement (CRADA) with them and partly funded by Nuclear Physics. I am both a theorist and an experimentalist.

Member Shea said she would be interested in any information Peggs has regarding breast cancer research and treatment.

Peggs said that research is being done at Loma Linda, and suggested visiting their website for information.

Member Henagan suggested looking on the Internet under Google Scholar for published papers on the topic.

#### **5. Community Comment**

There was no community comment.

#### 6. Membership Discussion and Vote

Hodgin said there is a proposal to change the membership status for Greg Bush and Bruce Martin from Individual members to an Education Organization. They would remain the primary and alternate members, respectively. The CAC's priorities for new organizations are qualification, interest, and commitment, so that is what we will be looking at as we discuss this proposal. The representatives have announced their intention and have attended and observed at least two CAC meetings. They now need to give a brief presentation to the CAC, which will include their interest, some background information, and the value that their organization will bring to the CAC. Reed said members of the audience are welcome to stay for this portion of the meeting, but if they would like to leave, that would be okay because the rest of the meeting will be organizational in nature.

Member Martin gave a brief history of their position on the CAC. He said 15 years ago when the CAC was organized there was a membership category for Education. That status was subsequently changed from Education to Individual. Recently, we have been in touch with an organization called Foundation for Economic Education (FEE), which also has a national Long Island discussion group. They are interested in sponsoring Greg Bush's membership on the CAC, with Martin as the alternate. He said under the new rules, there needs to be an organization and their original organization is no longer functional, so FEE has stepped in.

Hodgin asked how this organization will bring value to the CAC.

Member Martin said throughout the years during the sequence of educators that have been on the CAC, the members have made contributions to the discussions. Professor Bush, being an economist, has looked at various cost-benefit proposals and has gotten involved in the technical issues as well.

Member Sprintzen asked how many members are in the organization, how often they meet, what are the topics of discussion, and what kind of activities they engage in.

Member Martin said there are two organizations; on a national and local level. On a national level, I would guess there are a few thousand members. They sponsor seminars and give presentations. Some are by economists, some are philosophical. The local discussion group has been in existence for eight or ten years and they have sponsored seminars at local libraries and Suffolk Community College. They have monthly meetings with about 30 in attendance. There are 65 members of the group.

Member Peskin asked if the organization knows anything about Brookhaven National Lab.

Member Martin said the Operations Director is quite familiar with the Lab and he was eager to sponsor us. Their knowledge of Brookhaven is from afar. There are 15 local members that are aware of the Lab and concerned about what goes on here.

Member Martin asked to have Adam Martin removed as an alternate member, at his request.

Member Giacomaro asked if anyone from the Lab had ever presented at one of FEE's meetings.

Martin said no, but he would make that suggestion if the Lab's Public Relations Office thinks that would be appropriate.

Member Henagan asked what their mission statement is. I have been told this is a libertarian organization. Is this truly educational or a political organization.

Martin replied that he didn't have a formal statement, but would say the mission is to promote economic education. Some of the members, including myself, are libertarians. It is not a political organization. It's free market economics.

Member Sprintzen said it appears to be a right-wing libertarian organization, with an ideological perspective, which I don't share, but it's clearly an appropriate organization.

Hodgin said let's avoid using politically charged words. He then asked Member Martin to leave the room so the CAC could discuss the proposal.

The CAC discussed including the Foundation for Economic Education as a CAC Member organization represented by Greg Bush and Bruce Martin as the Member and Alternate, respectively.

A vote was taken and unanimously approved to invite FEE to join the CAC as an education organization under Education, Science & Technology and remove Member Bush from the Individual category.

Nora Sundin, liaison to the CAC, said the Lab has been reaching out to those members who have not met the attendance requirements. We have reached out several times to the IBEW. They have not returned phone calls or emails. We are asking for a vote on whether or not to remove the organization from CAC membership.

Hodgin said all the steps have been taken that are in our guidelines, so now it is time to take some action.

Member Schwartz asked what steps were taken to reach the organization.

Sherry Johnson, BNL Stakeholder Relations Office, reported that phone calls were made, emails were sent, letters were sent through the mail, and a letter was also sent to the President of IBEW Local 2230 asking if they want to appoint a new member. This has been going on for four or five months with no response. They are required to attend two thirds of the meetings and the last time someone was here to represent the organization was January 2013. The letter that we send out notifying them that they are being removed from membership gives them the opportunity to attend the next meeting and state their case and request to be put back on the membership role.

Member Peskin said this is an important organization to have represented at the CAC, because IBEW is the lead bargaining unit of all onsite union activities.

Member Giacomaro said perhaps make an effort to contact someone higher than the President of the local union.

Member Henagan suggested making a phone call to the President of IBEW.

Sundin said we can do that.

Hodgin said IBEW is very important, therefore an additional effort could be made to contact Phil Pizzo before taking a vote to exclude them.

Member Peskin said we could hold a vote, but hold off on taking action until contact is made.

Hodgin said the vote could be taken and a letter sent that states that BNL is going to work to reestablish the relationship. A vote was taken to rescind the membership of the IBEW contingent on first making an additional effort to contact them.

The motion is approved unanimously

Hodgin said BNL will reach out again to the IBEW and ask for a response before the next meeting to recover their membership.

#### 7. June Agenda Setting

Sundin said there will be a tour of NSERC at 5 PM before the June meeting, an update on the NSLS-II, and the environmental update that was scheduled for tonight. There will be no meeting in July or August.

#### 8. Agenda setting exercise for FY15
