## SUMMARY ANNUAL REPORT FOR BROOKHAVEN SCIENCE ASSOCIATES, LLC RETIREMENT PLAN

This is a summary of the annual report for the Brookhaven Science Associates, LLC Retirement Plan (Employer Identification Number 11-3403915, Plan Number 001) for the plan year January 1, 2023 through December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single employer, defined contribution plan with the following characteristics: money purchase and total participant-directed account.

## **Basic Financial Statement**

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$59,979,892. These expenses included \$167,137 in administrative expenses and \$59,812,755 in benefits paid to participants and beneficiaries. A total of 5,606 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,410,735,256 as of the end of the plan year, compared to \$1,251,409,519 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$159,325,737. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$219,305,629, including employer contributions of \$30,239,729, other income of \$1,953,372, and earnings from investments of \$187,112,528.

## **Minimum Funding Standards**

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
