

**SUMMARY ANNUAL REPORT FOR
BROOKHAVEN SCIENCE ASSOCIATES, LLC COMPREHENSIVE WELFARE BENEFITS PLAN**

This is a summary of the annual report of the Brookhaven Science Associates, LLC Comprehensive Welfare Benefits Plan, EIN 11-3403915, Plan No. 501, for the plan year January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Brookhaven Science Associates, LLC has committed itself to pay certain medical, dental and severance pay claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Magellan Behavioral Health, Ace American Insurance Company, Prudential Insurance Company of America, Delta Dental of New York, Inc, Lincoln National Life Insurance Company, Aetna Life Insurance Company and EyeMed Vision Care to pay certain accidental death and dismemberment, long term care, dental, life, long-term disability, health, vision and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2022 were \$4,094,088.
