Aetna Rx Home Delivery® mail-order pharmacy:

- Reorder only once every three months — online, by phone or by mail.
- Receive your medicine in private, secure packaging.
- Talk to a pharmacist by phone, any time of the day or night.
- Plus, you can easily order refills and manage your prescriptions anytime. Log in to www.aetnavigators.com, your secure member website.

CVS/pharmacy near you:

- Pick up your medicine at a CVS/pharmacy retail location that is convenient for you.
- Enjoy same-day prescription availability.
- Talk with a pharmacist face-to-face.

To pick up at CVS/pharmacy	You can do so quickly and easily. Choose the option that works best for you: <ul style="list-style-type: none">• Log in to www.aetnavigators.com. Click "Find a Doctor, Pharmacy or Facility" to find a CVS/pharmacy near you.• For new orders — If you have a new prescription for a 90-day supply, please ask the pharmacist to fill it. You can also call the toll-free number on your member ID card and we'll handle the rest.• For refill orders — To refill an existing prescription, bring your current medicine to the pharmacist and ask for a 90-day refill through the Maintenance Choice program.
To sign up for Aetna Rx Home Delivery mail-order pharmacy for the first time	Submit your order using one of these options: <ol style="list-style-type: none">1. Mail — Get a new 90-day prescription from your doctor. Mail it to us with a completed order form. Access the order form online. Log in to www.aetnavigators.com, then click "Aetna Pharmacy."2. Fax — Ask your doctor to fax your new prescription, with your completed order form to 1-877-270-3317. Make sure your doctor includes your member ID number, your date of birth and your mailing address on the fax cover sheet. Only a doctor may fax a prescription.3. Phone — Call us toll-free: 1-888-RX AETNA (1-888-792-3862) or TDD: 1-800-823-6373. With our Aetna Rx Courtesy StartSM program, we will contact your doctor to attempt to get a new prescription. Your doctor may require you to schedule a visit before he or she will write you a new prescription. After we reach out to your doctor, please allow adequate time (up to 7 days) for us to receive a reply. To help this process move quickly, we highly recommend you alert your doctor to expect our outreach.

With Maintenance Choice, you are covered to fill a set amount of 30-day fills at any pharmacy in our network. After that, your plan will cover 90-day fills through Aetna Rx Home Delivery or a CVS/pharmacy. Before you reach your 30-day fill limit and your out-of-pocket cost increases, we will contact you to help you get started with Maintenance Choice. We'll then help you get a prescription from your doctor for a 90-day supply. Then you can choose to fill it through Aetna Rx Home Delivery or at a CVS/pharmacy. Your privacy is important to us. Our employees are trained regarding the appropriate way to handle your private health information.
