This is a summary of the annual report for the Brookhaven Science Associates, LLC 401(K) Plan (Employer Identification Number 11-3403915, Plan Number 002) for the plan year January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single employer, defined contribution plan with the following characteristics: profit sharing, diversified investments meeting ERISA section 404(c), total participant-directed account, code section 401(k) feature.

Basic Financial Statement

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$45,861,023. These expenses included \$226,526 in administrative expenses, \$45,634,497 in benefits paid to participants and beneficiaries. A total of 3,629 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$948,964,302 as of the end of the plan year, compared to \$843,297,494 as of the beginning of the plan year. During the plan year, the plan experienced a change in its net assets of \$105,666,808. The plan had total income of \$151,527,831, including employee contributions of \$30,251,225, rollover contributions of \$15,487,474, other income of \$1,538,858 and earnings from investments of \$104,250,274.
