**Budget and staffing changes** – discuss any substantial or significant changes in library budget or staffing since last annual meeting and the expected impact on your library/organization.

We currently have fantastic support from the Deputy for Science at our Lab, and she has protected our Collections budget, even building in some resources to cover inflation. We are preparing to post a job for an entry level Librarian to assist with some of our reference work and support to the Lab Director's Office.

Our Technical Information Officer currently resides in the Library, but we are reevaluating our staffing allocations in that area. We are considering moving the TIO to Records or Lab Protection Division, and possibly adding an additional staff person.

We are attempting to procure Lab support to renovate our physical space into an "information hub" which will attract younger researchers and be a hospitable place for people to collaborate. The Library has been offering a variety of sessions

to educate early career researchers on publishing, and collaborating with the technical communications staff to develop a framework for research excellence.

The Library is part of the Office of Research Excellence, which is a new organization, but which is currently undergoing a change of scope. This has created a little bit of stress and confusion, but the Library is the most autonomous portion of the Office, so we are just continuing with our Library Mission to the best of our ability while everything else gets sorted

We are still very interested in procuring and implementing an Institutional Repository. As yet there has been no movement on this. One of the Subject Matter Experts in our parent organizations was going to lead this effort, but she left for a job elsewhere in our Lab, and so there is not currently an active plan for how to proceed.
